SUBJECT: Student Parking Permits

All 11th and 12th grade students who wish to drive to school this year will be required to apply for and purchase an annual parking permit for \$25.00. This year, advance parking permit purchase is being offered in an effort to “avoid the rush” when school begins. Our student lot will accommodate 460 vehicles and permit sales will be closed after those spaces are sold. Due to the limited spots, there will be parking spaces available for Seniors and Juniors only! Students will not be assigned a specific parking space. Parking will be based on who gets here first in the morning. Registration schedule below:

Parking Permits will be available for purchase in the Student Services and Athletic/Activities offices on the following dates:

***Seniors** may begin purchasing their parking permits on *Friday, June 11th & Monday June 14th* (11:45 A.M. – 2:30 P.M.)

***Juniors** may begin purchasing parking permits on *Tuesday, June 15th* (11:45 A.M. – 2:30 P.M.)

Pre-School Sales

***Seniors** may purchase parking permits and lockers on **August 10, 2010** (7:30 – 11:00) & (12:30 - 2:00)

***Juniors** may purchase parking permits and lockers on **August 11, 2010** (7:30 – 11:00) & (12:30 – 2:00)

Enclosed are a Parking Permit Registration form and a Student Entrance/Exit Gate map. The registration form must be completed (with all required signatures) and returned at the time of vehicle registration. A copy of each student's FLORIDA driver's license will be made at registration. Learner permits cannot be used to register for student parking. **NOTE:** Prior to purchasing a parking permit, all financial obligations (fees & fines) must be resolved with the school's bookkeeper, Mrs. Holloway.

Consequences for Parking Lot Infractions:

***OSS-A** student that receives Out-of-School Suspension could be subject to losing their parking privileges.
